
## DIRECT

During each distribution 25% will be distributed to the sponsors of 3 levels after the main sponsor who is the direct sponsor, these earnings will be distributed in this way, 10% for the sponsor of the direct sponsor, 10% for his sponsor and 5% for his sponsor.



So in summary, the sponsor will receive 40%, his sponsor 10%, his sponsor's sponsor 10% and his sponsor 5%

Which makes a total of 75%.

In case a sponsor is not available the system will look for a sponsor above him.


VIRTUAL TEAM



For the first time in the history of cryptocurrencies, we are introducing the concept of a virtual team, so what is a virtual team? The virtual team is a team that the system offers you without having to sponsor it directly.

At each level activation, the system checks if it is your first level to buy, if it is the case the system places you in a virtual team and selects a virtual sponsor for you, the system distributes to this virtual sponsor a part of the 25% and the rest to the potential virtual sponsor in the system.






## **Al Selection**

Our virtual sponsor selection system is based on an intelligent algorithm that selects users fairly.

Every user has the same chance of being selected, whether he can have a team or not. But he can receive the earnings of his virtual downline only if he has the required level.

### VIRTUAL DISTRIBUTION



10% of the investment is distributed to the virtual sponsor, 10% is distributed to his potential sponsor and 5% to the sponsor of his sponsor which makes a virtual distribution of 25%.

in the case where a sponsor does not have a level the funds are redistributed to the last user to have purchased a level in the system



## **ROYALTY INCOME**



10% of each investment will be reserved for monthly gains that certain leaders who have reached certain limits will be able to benefit from.
